Separated. Fill in the Unmarried oval on Line 19a of your PA-40, only if: (a) you are separated pursuant to a written agreement, or (b) you are married, but separated and living apart for the last six months of 2002.
Married. Fill in the Married oval on Line 19a of your PA-40, and enter your spouse's SSN and name above. Fill in the oval that describes your situation.
Married and claiming TAX BACK/Tax Forgiveness together with my spouse.
Married and filing separate PA tax returns. Certification. Fill in this oval certifying that you and your spouse are submitting the same information on each PA Schedule SP.
Married with a spouse who is a dependent on his or her parent's PA Schedule SP. Enter the SSN(s) and name(s) of your spouse's parent(s).

Married with a spouse who is a dependent on the Federal Income Tax return of another person. Enter the SSN and name of that person.

If Married, use the Your Income and Spouse Income columns. Add the totals and use the Joint Income total. Report income that is not taxable for PA purposes on Lines 2 through 10. See the instructions.
